- 2. Rubber tires are placed in the front & in pathway of the equipment crossing the tracks, thereby protecting the rail tracks.

  Under all circumstances, only equipment outfitted with rubber tires can cross railways, and pertinent to all CN/CP track crossing policy.

- 1. During the moment of contravention of Policy No. 2023/02 by a member of the public; for one time, directed at the offending person, person(s) or a group, Council or Administration will explicitly request the member of public to reframe and stop all acts in contravention of Policy No. 2023/02.
- 2. If the member of public continues in contravention of Policy No. 2023/02, they will be asked to leave the premise immediately.
- 3. If the member of public continues in contravention of Policy No. 2023/02, and refuses to leave the premise, the RM of Reford will contact the RCMP.

Under the pretense of points #1-#3, this will result an evaluation for up to a 6month ban from all RM of Reford Public Meetings, which will be confirmed by Council; through vote, after a reasonable 'cooling off' period.
